6.1 Red Lake-Ear Falls Detachment Board Report – Q1- 2025.

Trends:

- Youth charges are up. Inspector Illman will order a youth occurrence report.
- Inspector Illman will obtain mental health acceptance rates to determine how we compare/why there is a refusal for assistance.
- Violent crime is in a steady downward trend.
- Feb/October have the highest reported crime; there is an increase of reported violent crime on weekends.
- Assault is at the top of the list for Top 10 Violent Crimes by Most Serious Violation Code for the years 2022-2024.
- October and July have the highest reported Property Crimes for 2022-2024, with property crimes mostly occurring on a Wednesday/Thursday.

Staffing:

- The detachment currently has seven (7) constable vacancies.
- Another ERT member will be added to the detachment.

The Administrator reported the Board website is a work in progress and will be reviewed by the Board, prior to publishing.
