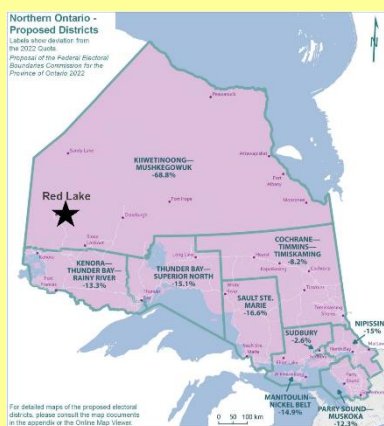
Federal Electoral Districts Redistribution

The Federal Electoral Boundaries Commission for Ontario is proposing new changes to the federal electoral boundaries in Ontario. These changes have potential negative impacts.

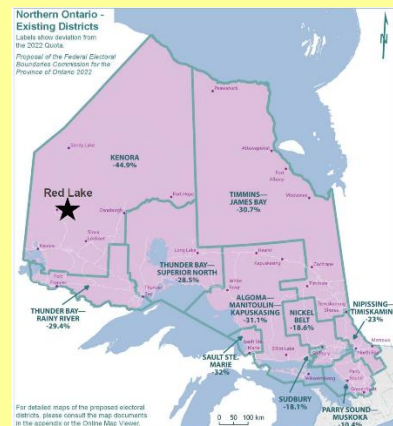

Take Notice that tenders are invited for the purchase of the land described below and will be received until 3:00 p.m. local time on September 21, 2022, at the Red Lake Municipal Office, 2 Fifth Street, Balmertown Ontario. The tenders will then be opened in public on the same day as soon as possible after 3:00 p.m. at the Red Lake Municipal Office, 2 Fifth Street, Balmertown.

According to the last returned assessment roll, the assessed value of the land is \$85,000. **Minimum tender amount: \$22,812.29**

Tenders must be submitted in the prescribed form and must be accompanied by a deposit of at least 20 per cent of the tender amount, which deposit shall be made by way of a certified cheque/bank draft/ money order payable to the municipality.

Except as follows, the municipality makes no representation regarding the title to or any other matters relating to the land to be sold. Responsibility for ascertaining these matters rests with the potential purchasers. The assessed value, according to the last returned assessment roll, may or may not be representative of the current market value of the property.

Transfers of properties that contain at least one and not more than six single family residences and are transferred to non-residents of Canada or foreign entities, are subject to the Province's Non-Resident Speculation Tax (NRST). This sale is governed by the *Municipal Act, 2001* and the Municipal Tax Sales Rules made under that Act. The successful purchaser will be required to pay the amount tendered plus accumulated taxes and any taxes that may be applicable, such as a land transfer tax and HST. The municipality has no obligation to provide vacant possession to the successful purchaser.

Hydrant Flushing

Please be advised that hydrant and water distribution system flushing within the communities of Red Lake, Balmertown, Cochenour, McKenzie Island and Madsen will begin on **September 19, 2022** for approximately **6 weeks**. During the flushing process, there should be no interruptions to water service. Common and temporary effects of the flushing process include a slight drop in water pressure and/or cloudy/discoloured water.

There are no health risks with using the water. However, household cleaning, laundry and food preparation should be postponed while local flushing is being completed. Upon completion, consumers should open a cold water tap for a few minutes until the water appears clear.

2022 Municipal Voters' List

Notice is hereby given that the list of all persons entitled to be electors for municipal elections in this municipality has been prepared by the Clerk's office. As of September 1, 2022 all electors should ensure that their names and relevant information are correct on the Voters' List. A person may make an application to the Clerk requesting that their name be added to or removed from the Voters' List or that information on the Voters' List relating to them be amended by completing and filing the prescribed form available at: **The Office of the Clerk, The Corporation of the Municipality of Red Lake, 2 Fifth Street, Balmertown, ON, P0V 1C0** during regular office hours between September 1st, 2022 to October 21st, 2022 and to the close of voting on October 24th, 2022. The application shall be in writing and shall be filed in person, or by mail, email or fax by the applicant or his/her agent. Proof of identity and residence as prescribed in O. Reg. 304/13 will be required of the applicant. If the applicant does not appear in person, a certified copy showing proof of ID and proof of residence/occupancy is required.

Qualifications of Electors

A person is entitled to vote in a municipal election if he or she on voting day:

- resides in the local municipality, or is the owner or tenant of land in the municipality, or the spouse of such owner or tenant; and
- is a Canadian citizen; and
- is at least 18 years old; and
- is not prohibited from voting by law.
