

## NOTICE OF DECISION FOR OFFICIAL PLAN AMENDMENT FILE D09-24-01 ZONING BY-LAW AMENDMENT FILE D14-24-05

Planning Act, R.S.O. 1990, c.P.13, s. 34

**NOTICE** is hereby given, that the Council of The Corporation of the Municipality of Red Lake passed By-Law Nos. 48-2024 and 49-2024 at a Council Meeting held Monday, September 16<sup>th</sup>, 2024, thereby giving approval to an Official Plan Amendment and Zoning By-Law Amendment.

**LOCATION OF PROPERTY:** 12 Dexter Road, Balmertown. Refer to the location sketch.

## PURPOSE AND EFFECT OF BY-LAW:

- Change the designation of the subject property from Townsite Employment to Townsite Residential.
- Change the zoning of the subject property from site specific Townsite Commercial (C1-p) to site specific Townsite Residential Density 1 (R1-8)
- Permit a multi-unit dwelling with 3 units and parking that exceeds 50% of the front yard.

THE LAST DATE FOR FILING A NOTICE OF APPEAL is Tuesday, October 8<sup>th</sup>, 2024.

## OTHER PLANNING APPLICATIONS RELEVANT TO THE SUBJECT LOCATION: None

Notices of appeal:

- i. must be filed with the Clerk of The Corporation of the Municipality of Red Lake;
- ii. must set out the reasons for the appeal; and
- iii. be accompanied by the fee prescribed by the Tribunal, payable to the Minister of Finance, Province of Ontario.

Only individuals, corporations and public bodies may appeal a by-law to the Ontario Land Tribunal. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.

No person or public body shall be added as a party to the hearing of appeal unless, before the by-law was passed, the person or public body made oral submissions at a public meeting or written submissions to the council or, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.
