BEING A BY-LAW TO AMEND BY-LAW 902-07 A BY-LAW TO REGULATE YARD MAINTENANCE

WHEREAS the Council of The Corporation of the Municipality of Red Lake approved By-Law No. 902-07 on July 17th, 2007; and

WHEREAS it is deemed necessary to amend By-Law No. 902-07; and

NOW THEREFORE the Council of The Corporation of the Municipality of Red Lake hereby **ENACTS AS FOLLOWS:**

1. Addition of:

"Sign" shall mean a display of any letter, figure, character, mark, point, plane, design, poster, pictorial, stroke, stripe, line, trademark, reading matter, or illuminating device constructed, attached, erected, fastened or manufactured in any manner whatsoever so that the same is used or is intended to be used for the attraction of the public and displayed in any manner whatsoever, and includes the structure of the said display.

6.13 Signs

- 6.13.1 No Owner of Land shall place a Sign(s) on the Land prior to two weeks before an event and shall remove them within seven days after the event ends.
- 6.13.2 No Occupant of Land shall place a Sign(s) on the Land prior to two weeks before an event and shall remove them within seven days after the event ends.
- 6.13.3 The signs shall be maintained in good condition and shall be appropriate in material, size, number and location, as determined by the By-Law Enforcement Officer.

6.14 Exemptions from Section 6.13

- 6.14.1 Signs may be placed on the Land if in compliance with the Home-Based Business section of the Zoning By-Law.
- 6.14.2 For Election purposes Signs may be placed on the Land if in compliance with the Clerk's Election Procedures.
- THAT By-Law No. 902-07 is hereby amended.
- THAT this By-Law shall come into force and take effect upon the final passing hereof.

WHEREAS it is deemed necessary to amend By-Law No. 902-07;

NOW THEREFORE the Council of The Corporation of the Municipality of Red Lake hereby **ENACTS AS FOLLOWS**:

- 1. Deletion of:
 - (i) 6.3 Grass to be kept Trimmed
 - 6.3.1 No Owner of Land shall fail to keep the grass and/or weeds upon the Land trimmed so as not to exceed thirty (30 cm) centimeters in height.
 - 6.3.2 No Occupant of Land shall fail to keep the grass and/or weeds upon the Land trimmed so as not to exceed thirty (30cm) centimeters in height.
- 2. Addition of:
 - (i) 6.3 Grass to be kept Trimmed
 - 6.3.1 No Owner of Land shall fail to keep the grass and/or weeds upon the Land trimmed so as not to exceed twenty (20 cm) centimeters in height.
 - 6.3.2 No Occupant of Land shall fail to keep the grass and/or weeds upon the Land trimmed so as not to exceed twenty (20 cm) centimeters in height.
- 3. THAT By-Law No. 902-07 is hereby amended.
- THAT this By-Law shall come into force and take effect upon the final passing hereof.
