BY-LAW No. 55-2022

**BEING A BY-LAW TO AMEND BY-LAW NO. 1739-13,
BEING A BY-LAW TO LICENCE, REGULATE AND
GOVERN OWNERS AND DRIVERS OF CABS, MOTOR AND
OTHER VEHICLES USED FOR HIRE**

WHEREAS the Council of The Corporation of the Municipality of Red Lake passed By-Law No. 1739-13 on February 19th, 2013; and

WHEREAS the Council of The Corporation of the Municipality of Red Lake passed By-Law 06-2015 on January 19th, 2015, to amend By-Law No. 1739-13;

WEREAS it is deemed necessary to amend By-Law No. 1739-13, to amend the fees in Schedule A;

NOW THEREFORE the Council of The Corporation of the Municipality of Red Lake hereby **ENACTS AS FOLLOWS:**

1. Deletion of:
 - (i) Schedule "A" – Fees.
2. Addition of:
 - (i) Schedule "A" Fees.

The said replacement is attached hereto as Appendix "A" and inscribed with the words "Revised by By-Law No. 55-2022 adopted on June 27th, 2022" and forms a part of this By-Law.

3. **THAT** By-Law No. 1739-13 is hereby amended.
4. **THAT** By-Law No. 06-2015 is hereby repealed.
5. **THAT** this By-Law shall come into force and take effect on July 15, 2022.

Schedule A
Fees

1. Waiting Time- \$70.00 per hour.

2. Meter Rates: (Red Lake Only)

2.1 \$7.00 for the first 1/20 kilometer or part therefore:

2.2 \$0.15 for every 1/25 of a kilometer or part therefore:

2.3 \$12.00 minimum rate for a parcel delivery within the municipality.

These rates include H.S.T.

3. Set Rates:

Red Lake	to	Balmertown	\$35.00
Red Lake	to	Cochenour	\$40.00
Red Lake	to	Madsen	\$35.00
Balmertown	to	Cochenour	\$30.00
Balmertown	to	Madsen	\$55.00
Cochenour	to	Madsen	\$60.00

Set rates same price when locations are reversed.

- An additional \$11.00 is added to the Cochenour trips if the drop off location is McKenzie Island (winter only).

4. Same Townsite Pick-up and Drop-off:

4.1 All trips deemed to originate from Red Lake therefore set rates in Item 3 above shall apply.

4.2 Exception:

- i) A meter shall be used only when pick-up and drop-off location is within Red Lake.
- ii) The meter shall not be activated until the passenger is in the taxicab.

5. Seniors Discount:

Any person who has attained the age of sixty-five (65) shall be entitled to a discount of ten percent (10%) from the metered or set rate.
