



**NOTICE OF COMPLETE APPLICATION AND PUBLIC MEETING FOR
MINOR VARIANCE TO THE ZONING BY-LAW FILE NUMBER: D13-26-04**

At the date and location below, the Municipality of Red Lake Committee of Adjustment will be hearing comments on an application for Minor Variance for lands described legally as Part 1, Plan 23R-12193 which is located in Part of Block S and Part 9, Plan M-355 and located at 30 Gustafson Street, Red Lake, ON (see key map on page 2).

DATE AND TIME OF HEARING: Tuesday, June 9th, 2026 at 5:00 p.m.

MEETING LOCATION: Council Chambers of the Municipal Office at 2 Fifth Street, Balmertown, in the Municipality of Red Lake.

PURPOSE AND EFFECT of the APPLICATION: The applicants have requested relief from the following provisions of the Municipality of Red Lake Comprehensive Zoning By-Law (1930-14) to construct a detached garage:

1. Relief from Section 3.2 (g)(i) of the Zoning By-Law to increase the maximum height of a detached garage from 4.5 m (14.76 ft) to 5.4 m (17.72 ft).

OTHER APPLICATIONS: There are no other Planning Act applications in process related to this property.
